



## Financial Verification for International Students ~ Undergraduate

United States government regulations require that certification of admission be based on both academic acceptance and evidence of adequate funds to meet all expenses for a student's proposed course of study.

This *Financial Verification for International Students* provides verification that the applicant, family, and/or sponsor is providing the necessary financial support, along with financial statements showing sufficient funds to cover the student's schooling and other expenses during their intended period of study.

**Please provide documents to verify your financial declarations.** Examples of supporting documents include: current bank statements, letter from employer stating length of employment, and tax documents showing yearly income. Students need to keep a duplicate set of documentation - necessary to apply for a student visa.

All documents should be in English (or provide English translation) with monetary amounts expressed in U.S. dollars. **Complete this form in English and type or print neatly in ink.**
