General Rules:

1. No shot size large than 6 and no more than 3-dram equivalent powder load.
2. The use of drugs or alcohol prior to or during any shooting activities is strictly prohibited.
3. All members and their guests will conduct themselves in a courteous and sportsman like manner, and abide by the rules of safe gun handling.
4. All ammo and shotguns must be owner/user furnished.

Sporting Clays Rules:

1. All guns must remain unloaded and open when not in the shooting stand and when walking between stations.
2. Eye and ear protection is **MANDATORY** for all shooters and spectators.
3. Once in the shooting stand, your gun must always be pointed safely down range.
4. Everyone must remain on pathways and in designated shooting stands at all times.
5. Shoot only from designated shooting stands.
6. Please place your empty hulls and all other trash in the trashcans provided.
7. Each **SQUAD** is allowed only ONE free show pair per station.

Hunting Rules:

1. **SAFETY FIRST!** Guns are to remain unloaded until you are in the field.
2. Always keep our muzzle pointed up and away from people and dogs.
3. Keep your safety on until a bird gets up.
4. Keep yourself in a straight line with the rest of the group at all times.
5. Only shoot at birds that are in front of you between 10 o'clock and 2 o'clock positions.
6. **NEVER** shoot at a bird that is on the ground or flying below shoulder height. Hillsides are the exception to this.
7. Always be aware of where all people and dogs are before you shoot.
8. If your guide calls "**WAIT**" do not take the shot.
9. All hunters must wear blaze orange.
10. A guide and dog is provided for each hunt, however, hunters may use their own dog.
11. If hunters choose to use their own dog during a hunt, they agree to keep the dog under control at all times, return the dog to a kennel box and away from hunting areas and flight pens.
