1. EPP offers programs for shortage areas as identified by State of Nebraska and local school districts who participate in EPP's Education Advisory Committee. AETP and TEACH grants are available for candidates who are working toward completion of shortage area programs. 2. School partners join in and contribute to the program's decision-making processes through the Education Advisory Committee. Additionally, EPP uses survey data from program completers in their first, second, and third year and their school principals to assess the teaching effectiveness of program completers through their third year. 3. Special Education teachers are required to earn the bachelor's degree with all core subjects required, including additional math courses. They are also required to complete six credit hours of literacy methods coursework. 4. All Education candidates are required to take at least one three-credit hour course that prepares general education teachers to provide instruction to students with disabilities, EDUC 224 Teaching

Exceptional Learners or EDUC 593 Basic Foundations of Special Education and Inclusive Practices. 5., 6., and 7: All Education candidates are required to complete at least two three-credit hour courses that prepare them to provide instruction to limited English proficient students, low-income families, and students from urban and rural schools: EDPS 210 Educational Psychology & Child Development or PSY 511 Psychological Foundations to Teaching and Learning and EDUC 225 Diverse Classrooms and Human Relations or EDUC 532 Enhancing Learning Through Linguistic and Cultural Diversity.

The Education department has developed an ongoing Technology Plan focused on improvements to teacher preparation in this area, based on ISTE Standards, TPAK Framework, and feedback from members of the Education Advisory Committee who are leaders in local schools. 6. Universal design is taught and assessed explicitly in EDUC 324E Instruction and Assessment for Elementary/Middle and EDUC 324S Instruction and Assessment for Middle/Secondary. All candidates are required to successfully complete one of these courses with a grade of C or higher. Universal design is also required in student teaching and assessed with edTPA. 7. The Education department requires candidates to use a Lesson Plan format that is based on universal design. This universal design Lesson Plan format is taught and assessed in every Education course. The summative performance assessment for the program is the edTPA,

completed by each candidate during student teaching. The edTPA requires universal design for lesson planning and requires all candidates to demonstrate effective use of assessment to inform instruction.

One course (3 semester credit hours) that includes effectively teaching students with disabilities and participating as a member of individualized education program team is required for all Education candidates to successfully complete (with a grade of C or higher) prior to student teaching (EDUC 224 Teaching Exceptional Learners). Additionally, instructional methods courses for every program include methods for differentiation of instruction, science of reading, and assessment for diverse learners in the general education classroom.

1. Special Education teacher preparation requires coursework to prepare candidates for students with mild/moderate disabilities, learning disabilities, and behavior disorders. 2. Either 42 or 51 semester credit hours of coursework prior to student teaching are required and include American Sign Language, adaptive physical education, instruction, assessment, evaluation, IEPs, teaching students with mild disabilities, and teaching students with moderate disabilities. The number of credit hours is based on the State of Nebraska requirements for K-6 (42), K-12 (51), and 7-12 (42) Special Education endorsements. 3. Special Education teacher candidates are placed for student teaching with Special Education teachers who effectively teach students with disabilities. These candidates are required to perform on the student teaching summative assessment in teaching students with disabilities to the "Proficient" level.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

1. One course (3 semester credit hours) that includes effectively teaching students with disabilities and participating as a member of individualized education program team is required for all Education candidates to successfully complete (EDUC 224 Teaching Exceptional Learners). 2. Special education teacher preparation includes successful completion of EDUC 314 Assessment, Evaluation and IEP in which candidates must prepare, present, and assume various roles to participate in IEPs. 3. Special Education candidates are placed for student teaching with Special Education teachers and required to participate in IEP meetings to the extent that families and school districts will allow during student teaching.

c. Effectively teach students who are limited English proficient.
