# STATE AUTHORIZATION

Concordia University, Nebraska has been approved by Nebraska to participate in the <u>National Council for State Authorization Reciprocity Agreements (NC-SARA)</u>. NC-SARA is a voluntary, regional approach to state oversight of postsecondary distance education.



SARA is an agreement that permits approved institutions in member states to offer distance education outside of their state boundaries to students in other SARA member states under one set of policies and standards. If a state is not a member of SARA, institutions seeking to enroll students in the non-SARA state may be required to receive authorization from the state the student is located, according to that state's regulations. Institutions located in non-SARA states or institutions in SARA states choosing not to become an authorized institution, may be required to receive authorization from states they are seeking to offer distance education in.

Institutions are authorized to offer distance education in other SARA states by their home state portal entity. Nebraska became a SARA state August of 2014. Concordia University, Nebraska became an approved SARA institution in August of 2014. Nebraska's Portal Entity is the <u>Coordinating Commission</u> <u>for Postsecondary Education</u>.

# PROFESSIONAL LICENSURE

SARA does not have an effect on individual state professional licensing requirements and does not indicate certification or licensing approval. Candidates seeking certification should determine the licensure requirements in the state(s) in which they will be seeking certification before enrolling in an academic program. Written approval that this program will be acceptable for licensure by their state should be obtained prior to beginning the program.

Online and on campus teacher education programs and programs leading to licensure offered by Concordia University, Nebraska meet Nebraska requirements. Contact the State Department of Education in the state you are seeking certification or licensure before enrolling in online teacher education preparation programs at CUNE to ensure it meets requirements of the state in which certification is sought.
